



## R Bar Locker Rental

Thank you for your interest in our VIP Lockers! Buy your Premium bottles from us, we store them in your own Private Locker and we serve you when you come in!

### Pricing:

Locker rental is \$1000.00 Per Year including a \$400.00 Bottle Credit. All bottles are provided to you at a VIP Discount of 20% off our standard pricing. We will create an engraved sign for your designated locker with your business name. Only Premium Liquors can be purchased for inclusion in your Locker Stock.

Your annual price includes table service for you and your guests using your pre-selected bottle. Standard Mixers, Glassware and Ice are included in your service. There may be a small surcharge for more than 2 guests.

**Waiting List:** If no lockers are available at the time of application and you wish to be added to the wait list, a refundable \$50 holding deposit may be charged and you will be notified as soon as a locker becomes available.

### Tipping Policy:

Tips are not included in your VIP Service. You are responsible for tipping your bar staff for their service.

### Bottle Storage Policy:

A Minimum of 2 bottles must be maintained in your locker at all times. Only premium bottles purchased from R Bar can be maintained in your Locker. We can not store valuables or any other items in your locker.

Lockers are assigned as a first come first served basis.

# Locker Rental Agreement:

This agreement is between Desai Holdings (DBA R Bar) hereafter "Lessor" and the individual or entity listed below, hereafter "Lessee". Should this agreement change during the term of your rental a new agreement or addendum to this agreement may be required to be signed by you.

I understand and agree that R Bar (including owners, holding company, officers, agents, and employees) is not liable for damage or loss of property including, without limitation, loss, theft, or vandalism and the related expenses as a result of my use of the locker. I do hereby release R Bar from liability from any and all claims.

I understand that R Bar is renting me a locker for the sole purpose of storing bottles of alcohol purchased from R Bar to be consumed on the premises only. I further understand that I need to keep a minimum of 2 bottles in my locker at all times.

I understand that the only myself and those individuals I have included on this rental form in "allowed users" are able to request my locker be opened. "Allowed users" other than myself can access my locker and consume its contents with or without my presence.

I understand that all rental lockers remain the property of the R Bar and that the management of the bar reserves the right to suspend or revoke locker privileges without refund.

I understand that failure to renew my locker rental (including purchase of a minimum of 2 bottles) by the annual locker renewal anniversary will result in removal of my name as the locker holder and may result in the permanent reassignment of my locker to another person.
